A copy of the mares registration papers with current owner listed or lease agreement must accompany contract. The owner recorded on the registration certificate will be recorded on the stallion breeding report.

For purposes of this agreement, the breeding season shall begin February 3 and close July 2 of the year on this agreement.

The mare owner is guaranteed one "Live Foal". The term "Live Foal" means foal resulting from the breeding shall stand and nurse within twenty- four (24) hours. If a live foal does not result from the breeding, the Mare Owner will be entitled to rebreed the Mare the following season only, to the Stallion for no additional stud fee. Provided proper notification must be received within one week of the non-viable foal being born. Proper notification is defined as written certification by a licensed veterinarian that mare has slipped or produced a non-viable foal. If written notification is not received, the rebreed may not be honored at the STALLION OWNERS discretion. Mare Owner will be responsible for the cost and transport of additional Cooled Semen for the Rebreed Year

Stallion owner will require notification for breeding dates in order to submit a stallion breeding report for your mare. A Breeders Certificate will be issued only after mare owner has notified the stallion owner that the mare has produced a live foal and that all bills on the mare have been paid in full to stallion owner and KSU Horse Unit.

If the mare absorbs or aborts a pregnancy after having been checked in foal, or if the mare fails to conceive during normal breeding season, The Mare Owner is entitled to a rebreed the following season only and will be responsible for all shipping fees

In the event the above-named stallion dies or is unavailable, or becomes unfit for service, the stallion owner will offer a refund of Stallion fee or mare owner may have choice to use frozen semen if available. In the event the mare dies during the Breeding Season, the Mare Owner may substitute another mare as may be agreed upon by both Mare and Stallion Owner

In the event the Mare Owner's check is returned for insufficient funds, Mare Owner is responsible for a returned check fee in the amount of \$100.00 Reimbursement for a returned check and returned check fee must be made by money order, cashier's, certified or by credit card.

Warranty: No warranties whatsoever, expressed, or implied, shall accompany breeding transferred by this Agreement. No guarantee of delivery of shipped semen within a certain time period or guarantee that shipped semen will safely reach the insemination point without losing some integrity, quality or characteristics is given by this Agreement.

Should the mare be sold, the breeding provided by this contract as well as all terms of this contract transfer to the new owners with the written consent of Stallion Owner.

Color foal Guarantee for APHA MARES ONLY. If the resulting foal is solid in color and not eligible for regular paint registry as per current rules with the APHA registry the mare may be rebred in the following season only, provided the mare owner pays all shipping fees. Any foal which is solid in color must be DNA tested to ensure that it is not eligible for registry under RG 070 in order to qualify for the color rebreed guarantee. A mare owned by same owner may substitute upon approval of Stallion Owner. If the Mare Owner fails to rebreed the mare the subsequent breeding season, then any and all fees become forfeited, the right to rebreed is canceled and the Stallion Owner is released from all further obligations of this contract unless otherwise agreed in writing and signed by both parties.
